Terms & Conditions

- The **Access Card Program ("ACP")** is opened to all "**Principal Membership**" member's children upon expiry of their supplementary membership after reaching 18 years of age.
- Renewal of this program can be applied annually and up to **23 years of age**.
- Application of ACP may be made **one (1) month** before the expiry of the supplementary membership.
- Submission of ACP application form together with payment of a non-refundable fee as stated above must be made upon application of this program. The Management reserves the right to amend the joining fee without prior notice.
- The Management reserves the right to reject any application upon review without assigning any reason whatsoever thereto.
- A copy of **Birth certificate** and photocopy of **identification card** together with two (2) **photograph passport size** must be submitted upon application of this program.
- ACP is fixed for a duration of **360 days** only during which ACP Card Holder will get to enjoy the Club's facilities subject to terms and conditions herein stated.
- ACP Card Holder is strictly non-transferable and can only be used by the person whose name is imprinted on ACP Card.
- Any default, suspension or termination under Principal Membership shall automatically attract the same penalty(ies) under ACP which shall only be uplifted upon regularization of Principal Membership.
- In the event the member under Principal Membership intends to transfer and/or change corporate nominee(s), this ACP shall automatically be terminated.
- For lost or stolen ACP Cards, an administrative fee of **RM50.00** per card is chargeable for issuance of replacement ACP Cards.
- ACP Card Holder must at all times adhere to policies of **Bukit Jalil Golf & Country Resort (BJGCR)** in respect of matters such as club rules on proper golf/sports attire, golfing etiquette, booking procedures for golf/sports facilities and handicap requirements. Breaches may lead to suspension of this program.
- The Management of BJCGR reserves the right to add or remove any benefits of ACP and/or any of the above terms and conditions deemed necessary without prior notice.
- The Management of BJCGR reserves the right to revoke or terminate any ACP in the event it receives notice of any breach of these terms and conditions and/or abuse of usage by ACP Card Holder concerned and **no refund** whatsoever shall be made by BJCGR in the event of earlier termination of ACP howsoever caused.
- ACP Card Holder agrees to indemnify and keep Berjaya Hartanah Berhad against any actions, demands, claims, proceedings, damages, costs, charges and expenses arising out of or made in consequence of ACP Card Holder's breach of the terms of this ACP or as a result of Operator granting this ACP and understanding the scope of responsibility herein contained.
